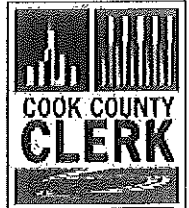

**TAX LEVY ORDINANCE
NEW TRIER TOWNSHIP
ORDINANCE NO. 2017-04**

An ordinance levying taxes for all town purposes for New Trier Township, Cook County, Illinois, for the tax year 2017, collectible in 2018.

BE IT ORDAINED by the Board of Trustees of New Trier Township, Cook County, Illinois, as follows:

SECTION 1: That the sum of Two million eight hundred fifty one thousand three hundred seventy-five dollars (\$2,851,375) is hereby levied upon all property subject to taxation within the township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the township as required by statute or voted by the people in accordance with the law, for such purposes as: Town General Fund, General Assistance Fund, for the fiscal year 2018-2019.

SECTION 2: That the amount levied for each object and purpose shall be as follows:




